Application for Membership

The undersigned (hereinafter called the Applicant) hereby applies for membership with Suwannee Valley Electric Cooperative, Inc (hereinafter called the Cooperative), upon the following conditions:

1. The Applicant assumes no liability of the Cooperative or responsibility for payment of any debts of the Cooperative by payment of a membership fee and becoming a member of the Cooperative.
2. The acceptance of this application by the Cooperative, after proper execution by the Applicant, shall constitute a contract between the Applicant and the Cooperative. If the Applicant shall not be approved as a member of the Cooperative by its Trustees, all fees submitted with this application will be refunded to the Applicant.
3. The Applicant agrees to become a member and comply with and be bound by the by-laws and all other governing documents. Governing documents are the membership application and the following documents and actions, all as currently existing or as later adopted or amended: (1) all Law regarding or affecting the Cooperative's property, property rights, and assets, the Cooperative's operation, the Cooperative's members and patrons, the provision and use of Cooperative services, Cooperative equipment and member equipment connected to Cooperative equipment; (2) Articles of Incorporation; (3) Bylaws; (4) Cooperative' rate tariffs, service rules and regulations, requirements, guidelines, procedures, policies, programs, determinations, resolutions, or actions taken, adopted, promulgated, or approved by the Board of Trustees.
4. Upon application, the Applicant(s) will provide the Cooperative with a valid photo ID, such as a driver's license or state issued ID, each Applicant's social security number and other contact information as required by Cooperative. The Applicant will deposit with the Cooperative the sum of \$5.00 which, upon acceptance of this application by the Cooperative's Trustees, will constitute the Applicant's membership fee.
5. Applicant will cause his/her premises to be wired in accordance with the National Electric Code and will maintain standards and clearances as provided by the National Electric Code, local inspection authorities and the Cooperative (Meter & Service Requirements).
6. The Cooperative shall provide electric energy service to Members in a reasonable manner. The Cooperative, however, does not insure, guarantee, or warrant that it will provide adequate, continuous, or non-fluctuating electric energy service. The Cooperative is not liable for damage, costs or expenses, including attorney fees or legal expenses, caused by the Cooperative providing inadequate, non-continuous or fluctuating electric energy service, unless the damages, costs, or expenses are caused by the Cooperative's gross negligence or willful misconduct. The Cooperative's responsibility and liability for providing electric energy service terminate upon delivery of the service at the meter to a Member.
7. Applicant agrees to consume, receive, purchase or otherwise use from the Cooperative all electric energy service at prevailing rates determined in accordance with the Cooperative's rate tariffs, service rules and regulations, requirements, guidelines, procedures adopted and promulgated or approved by the Board of Trustees.
8. Cooperative reserves the right to limit the amount of electric power which it shall be required to furnish to the Applicant.
9. Applicant expressly agrees that Cooperative personnel and approved contractors acting on behalf of Cooperative, shall have unlimited ingress, egress and access to Applicant's property for the purpose of construction and repair of service, reading and/or repairing meters, maintaining right-of-way clearance and other functions associated with Cooperative's business operations. By signing this application, Member gives Cooperative advance permission to perform these services as required.
10. Applicant has the ability to satisfy future requirements through an electronic signature. Applicant agrees to be bound with the same force and effect when using an electronic signature as if Applicant had affixed his/her signature on paper, by hand. Applicant agrees that clicking "Accept" or "initial" will constitute an electronic signature.
11. Applicant grants Cooperative the right to photograph and use Applicant's likeness for the purpose of publishing in any Cooperative relation publication, but not limited to the Internet, newsletter, and all other trade publications.
12. Upon acceptance into membership of the Cooperative, Applicant gives the Cooperative express consent to contact Applicant by email, text message, or phone call at all phone numbers, including cell phone numbers ("electronic communication") provided in this application or given to Cooperative in the future for the purpose of notification, collection, emergency purposes, or discontinuation of service. Applicant acknowledges that the Cooperative has made it aware that it may terminate these electronic communications at any time by contacting SVEC in writing to ask that SVEC no longer communicate with Applicant by using electronic communication.
